CEO OVERVIEW

2021 was a year of transitions at Child Impact International. After 13 years of service, Jim Rennie retired from his role as CEO. He moved back to his home country of New Zealand and continued to support Child Impact projects in India and Bangladesh. In August, I began my work as CEO of Child Impact. The organization had been led well and had a strong financial position with many programs benefitting vulnerable children globally. 2021 continued the upward financial growth and marked the highest revenue in Child Impact history, with over 4.2 million in donations. This achievement was complemented by the highest December on record with close to \$700k in donations.

A highlight during the last quarter of 2021 and into the first quarter of 2022 was the opportunity to support many critical needs in the field through the "Where Needed Most" fund. Thanks to the generosity of donors, these resources were able to assist urgent needs, which enabled children to be served more effectively. Additionally, Child Impact's "Operation Child Rescue" initiative began to expand globally with new projects to fight human trafficking.

Big thank you to our previous CEO, Jim Rennie, for his vision and leadership that provided a strong foundation for continued growth. Also, thank you to the board of directors for their commitment to delivering the best programs possible. Finally, thank you to our donors, who are the lifeblood of this organization. Every dollar given is being put to work to make the biggest difference possible for as many children as God enables us to help.
