### **CEO OVERVIEW**

Every year, our team identifies five big wins for the year.

During 2023, the following initiatives made the top of the list:

**1. Growth and Impact of Operation Child Rescue**: In 2023, your support was crucial in opening rescue projects in four new countries—Colombia, Pakistan,

**2.** Increased Church Engagement: This year, we experienced the impact of advocacy when our supporters invited us to their churches to share the transformative stories of how Child Impact is changing the lives of children.

3. Monthly Giving to Operation Child Rescue: A total of 18 projects served 1,600+ children. Additionally, 2023 saw a growth of monthly donors (referred to as Rescue Party Members) who support our anti-trafficking project.

4. New child sponsorships exceeded 100 every month during 2023: Every sponsorship is significant. Families, couples, children, Sabbath school classes, VBS programs, classrooms, businesses, and dental offices have all sponsored students.

**5. Expansion of Falco's Children Village:** Through a major donation, Child Impact was able to expand the campus at Falco's Children Village in Tanzania. The construction of a multi-purpose building provides a gathering/recreation place that can be used

Financially, 2023 was a strong year, reaching over \$6 million in donations for the first time ever. This marked a more than 50% increase over the previous year and represents the ability to help more vulnerable children, both through fighting human trafficking and
